TO WHOM IT MAY CONCERN:

I, the undersigned, parent/legal guardian of \_\_\_\_\_, a minor, do hereby authorize the Pastor, Youth workers, and Sponsors of the participating churches to be agents for the undersigned, to consent to any x-ray examination, anesthetic, medical or surgical diagnosis or treatment and hospital care which is deemed advisable by, and is rendered under the general or specific supervision of any surgeon or physician licensed under the provisions of the Medical Practice Act on the medical staff of any accredited hospital, whether such diagnosis is rendered at the office of said physician or at said hospital.

It is understood that this authorization is given in advance of any specific diagnosis, treatment, or hospital care being required, but is given to provide authority and power on the part of our aforesaid agents to give special consent to any and all such diagnosis, treatment, or hospital care which the aforementioned physician in the exercise of his/her best judgment may deem advisable.

It is further understood that all effort will be made to get in touch with parent(s)/legal guardian(s) prior to use of this authorization.

This authorization shall remain effective until December 31 this year unless revoked earlier in writing and delivered to said agents.

## STUDENT CONTRACT

While attending a Spirit of Joy event, students shall:

- Respect the individual rights, safety, and property of others
- Avoid displays of overly affectionate behavior
- Not participate in obscene and/or discriminatory and/or demeaning language or roughhousing
- Not be insubordinate to chaperones or the leader in charge of the event
- Not possess or use weapons, alcoholic beverages, tobacco and/or illegal drugs at any event, activity, or meeting, or remain in the presence of individuals who possess or use these items
- Abide by all rules of the attended event, activity, or meeting
- Not leave the event site(s) without permission
- Pay any costs related to damage or destruction of property that he or she incurs
- Dress appropriately and modestly.

Penalties and/or disciplinary action for infractions of this code of conduct may include any or all of the following:

- Sending youth home
- Being held responsible for the cost of damages and repairs in the event of damage/destruction of property
- Releasing the member to the nearest law enforcement agency and/or the proper authorities for significant violations of state law

Youth Director will notify parents of any actions taken.
